TERMS & SPECIFICATIONS

I, the undersigned, do hereby allow myself or my minor child to participate in the City of San Marcos (City) art display event, and further understand and agree to the following on behalf of myself or my minor child:

Application Instructions: All applicants must complete and sign this Art Display Application. 5-7 entries may be submitted per applicant for each display period. Returning artists must submit different pieces than previously exhibited. Submission of an application does not guarantee approval by the City of art for public display, and the City reserves the right to reject any applications.

Rules and Regulations: I agree that the artist will comply with all rules and regulations of the City with respect to artist's public display of art at any City facility.

Submissions: The artist is responsible for delivering the art to the display location and retrieving the art from the display location at the end of the display period. All art submitted must be framed and ready to hang with wire mounted across the back (no sawtooths). The City may remove and/or destroy the art if the art is not retrieved within a reasonable time period following the end of the display period.

Loss or Damage: I understand that the City is not responsible for maintaining or protecting the art while on public display or in the possession of the City. I hereby release the City from any and all liability for loss or damage to the art while on public display or in the possession of the City. The City assumes no risk of loss or damage to the art after the acceptance of the art. In the event of physical loss or damage to the art while on public display, the City has the right to remove the art and return it to the artist.

Sale of Art: All transactions for the sale of any art sold during the display period shall take place directly between the artist and the buyer, and artist agrees to pay City a ten percent (10%) donation on each sale.

Waiver and Liability Release: I agree to unconditionally waive, release and discharge any and all rights that the artist and/or the artist's heirs, assigns, agents or other representatives may have or which may accrue, to file any claim, lawsuit and/or any other cause of action against the City and its directors, officers, agents, employees, and designees (collectively, City Indemnified Parties) as a result of the artist's public display of art at any City facility.

Indemnification: I agree to indemnify, defend, protect and hold harmless the City Indemnified Parties from and against any and all liability, claims, demands, costs and expenses (including, without limitation, court costs and reasonable attorneys' fees) of any kind whatsoever resulting from or in any way connected with property damage that may arise from the artist's public display of art at any City facility, including whether caused by the active or passive negligence of City Indemnified Parties, excepting acts caused by the sole negligence or willful misconduct of City Indemnified Parties.

Photograph Release: I give the City permission to take and use photos of the artist and/or the artist's art in its promotional materials and publicity efforts without further authorization and without any compensation. I understand that photographs may be used in a publication, print ad, direct-mail piece, electronic media (e.g. video, CD-ROM, Internet, Web), or any other form of promotion, and that they may be cropped or otherwise altered. I release City Indemnified Parties from liability for any violation of any personal and/or proprietary rights that the artist and/or the artist's parent/guardian may have in connection with such use.

False Information: I agree that City will not be responsible for anything that may happen as a result of false information given at the time of submission of this Art Display Application.
