2. Project No: Resolution PC18-4730, Project TA18-0001, CEQA Exemption 18-032

Applicant: City of San Marcos

Request: The Planning Commission will review proposed revisions regulating the business of massage, including proposed revisions to Title 5 of the San Marcos Municipal Code and Title 20 (Zoning Ordinance), but will only consider and make a recommendation to the City Council on the proposed Title 20 zoning and land use regulations that are within the scope of the Planning Commission's jurisdiction.

Environmental Determination: A Notice of Exemption (EX18-032) was prepared for this project in that the proposed Text Amendment is not defined as a "project" within the meaning of Section 15378 of California Environmental Quality Act (CEQA) Guidelines. Further, even if the proposed Text Amendment were defined as a project, the project would be exempt pursuant to 15061(b)(3) of the CEQA Guidelines because it can be seen with certainty that there is no possibility it would result in a significant effect on the environment.

PUBLIC COMMENTS

Rob Billups, representing Andaman Institute of Massage did not come forward when Chairman Norris opened the Public Hearing on Agenda Item No. 2 and noted there were no speaker slips. Rather, Mr. Billups' comments were made during the Public Hearing for Agenda Item No. 4, after the Commissioners closed the Public Hearing and voted on Agenda Item No. 2. Mr. Billups' comments related to requesting that the City translate the massage business operating requirements into Thai for those massage technicians who spoke Thai and/or were not proficient in English. Mr. Billups was advised by Chairman Norris that the Planning Commission could not take action on anything relating to his comments as voting had concluded on Agenda Item No. 2, and his comments concerned regulations under Chapter 5.44 of the San Marcos Municipal Code, which is not within the Planning Commission's jurisdiction. It was recommended by Chairman Norris that Mr. Billups address his concerns at the upcoming City Council hearing for the massage ordinance.

Applicant: El Dorado II, LP

Request: Specific Plan Amendment (Resolution PC 18-4741), Site Development Plan (Resolution PC 18-4742), and Tentative Parcel Map (Resolution PC 18-4743) for a 3.68-acre mixed-use development including the new construction of 72 affordable apartment units and 1,970 square feet of commercial space; remodel of an existing 12-unit affordable apartment building (303-305 Richmar Ave.); and a 0.56-acre community open space with playground equipment, picnic area, and small soccer field in the El Dorado Specific Plan Area (SPA). Project includes the demolition of 3 existing buildings.

Environmental Determination: Addendum of Mitigated Negative Declaration (ND13-009) was prepared pursuant to the California Environmental Quality Act (CEQA).
